4. Owner granted Restricted Stock Units under Cardtronics' annual Long Term Equity Incentive Plan. Restricted Stock Units are subject to the terms of said plan and each Restricted Stock Unit thereunder automatically converts to a common share at the rate of 50%, 25% and 25% of the total Restricted Stock Units granted on January 31st of the 2nd, 3rd, and 4th year following the plan year.
5. Owner granted Stock Options under Cardtronics' annual Long Term Equity Incentive Plan. Stock Options are subject to the terms of said plan and each Stock Option allows the Owner to purchase one common share. 33% of the total Stock Options granted become exercisable on January 31st of each of the 1st, 2nd and 3rd year following the grant year.
